### Mooring Numbers

The purpose of issuing members with mooring numbers is to enable the committee to manage the mooring area effectively. Every mooring should be marked with a float, upon which its number should be clearly marked. In addition **every piece** of equipment belonging to a member should also be marked with that number. This includes, dinghies, trailers, canoes, kayaks, oars, dug-up mooring blocks etc. As you will be aware, as of summer 2013 the RABC now has a new constitution. In addition, the committee have agreed on a new set of Mooring Regulations (**Club Rules**), which have been distributed to members and are on the RABC web site. These should be consulted before you sign this form to ensure that you comply. These rules are to ensure that the “aims of the club” as set out in the constitution are met for the benefit of both members and the wider community of which the club forms a part.
